SUBJECT: MOTION TO AUTHORIZE & APPROVE FOR RESOLUTION FOR MANDATORY FINANCIAL LITERACY TRAINING FOR ALL CROW CREEK SIOUX TRIBAL EMPLOYEES

- WHEREAS:** THE CROW CREEK SIOUX TRIBAL COUNCIL IS THE OFFICAL AND GOVERNING BODY OF AND FOR THE CROW CREEK SIOUX RESERVATION; AND,
- WHEREAS:** UNDER THE CONSTITUTION AND BY LAWS OF THE CROW CREEK SIOUX TRIBE, THE TRIBAL COUNCIL IS EMPOWERED AND AUTHORIZED TO ENACT RESOLUTIONS AND ORDINANCES GOVERNING THE MANAGEMENT OF ALL ECONOMIC AND EDUCATIONAL AFFAIRS AND ENTERPRISES OF THE TRIBE; AND
- WHEREAS:** THE CROW CREEK SIOUX TRIBAL COUNCIL HAS THE AUTHORITY AND RESPONSIBILITY TO OVERSEE ALL TRIBAL MATTERS ON THE CROW CREEK SIOUX INDIAN RESERVATION; AND,
- WHEREAS:** THE CROW CREEK SIOUX TRIBE HAS A STRONG DESIRE FOR ALL TRIBAL EMPLOYEES TO BE EMPOWERED TO EFFECTIVELY MANAGE THEIR PERSONAL AND TRIBAL FINANCES; AND,
- WHEREAS:** THE CROW CREEK SIOUX TRIBE WHOLEHEARTEDLY SUPPORTS IMPROVED FINANCIAL LITERACY ON THE CROW CREEK RESERVATION; AND,
- WHEREAS:** HUNKPATI INVESTMENTS IS A CERTIFIED NATIVE COMMUNITY DEVELOPMENT FINANCIAL INSTITUTION WITH A MISSION TO PROMOTE THE SELF-SUFFICIENCY, SELF-DETERMINATION, AND AN ENCHANCED QUALITY OF LIFE FOR THE CROW CREEK RESERVATION; AND,
- WHEREAS:** HUNKPATI INVESTMENTS PROVIDES QUALITY FINANCIAL LITERACY TRAINING THAT IS USED BY MANY TRIBAL MEMBERS; AND,
- WHEREAS:** HUNKPATI INVESTMENTS AND THE CROW CREEK SIOUX TRIBE HAVE A STRONG PARTNERSHIP AND OFTEN WORK TOGETHER ON PROJECTS FOR THE GOOD OF THE CROW CREEK RESERVATION; AND,
- WHEREAS:** OTHER LOCAL TRIBES, SUCH AS THE CHEYENNE RIVER SIOUX TRIBE, HAVE ADOPTED MANDATORY FINANCIAL LITERACY TRAINING FOR TRIBAL EMPLOYEES; AND,

NOW THEREFORE BE IT RESOLVED: THAT THE CROW CREEK SIOUX TRIBAL COUNCIL ASSEMBLED IN REGULAR SESSION THIS 12TH DAY OF MARCH, 2013, DOES HEREBY MAKE IT MANDATORY FOR ALL TRIBAL EMPLOYEES TO PARTICIPATE IN FINANCIAL LITERACY TRAINING TO BE PROVIDED BY HUNKPATI INVESTMENTS; AND,

BE IT FURTHER RESOLVED THAT: ALL DEPARTMENTS OF THE CROW CREEK SIOUX TRIBE ARE OBLIGATED TO WORK WITH HUNKPATI INVESTMENTS TO SCHEDULE THESE CLASSES AT A TIME AND DATE THAT ARE CONVENIENT TO THE DEPARTMENT BUT SHALL WITHIN ONE YEAR OF THE PASSING OF THIS RESOLUTION; AND.

FURTHERMORE LET IT BE RESOLVED THAT: THE CROW CREEK SIOUX TRIBE DOES ALLOW HUNKPATI INVESTMENTS TO USE TRIBAL FACILITIES, SUCH AS THE LODGE STAR CONFERENCE ROOM, AND TO PROVIDE THIS TRAINING AT NO COST.

SECTION 1 OF THE CONSTITUTION OF THE TRIBE, RATIFIED BY THE TRIBE ON MARCH 11, 1949 AND APPROVED BY THE SECRETARY OF THE INTERIOR ON APRIL 26, 1949 AND WITH AMENDMENTS APPROVED BY THE COMMISSIONER OF INDIAN AFFAIRS ON JUNE 22, 1961, FEBRUARY 25, 1963 AND BY THE AREA DIRECTOR ON JUNE 23, 1980.
